About the Speakers

James Love

James is a solicitor–advocate with 30 years' experience specialising in intellectual property, including handling disputes in the Supreme Court. He recently joined international legal practice Womble Bond Dickinson as a partner, after having run his own successful IP boutique, James Love Legal, for 13 years. James was a member of the Law Society Intellectual Property Law Committee for 10 years, during which time he assisted the government on the implementation of the Trade Marks Directive, sat on the UKIPO Trade Marks and Designs Forum, and worked in conjunction with the Law Commission on the reform of "threats" legislation. He currently sits on the Law Society International Committee. James' views have been sought on national television and radio, as well as being quoted in the national and international press such as the FT and the South China Morning Post.

Dai Davis

Dai Davis is a technology lawyer. He holds Masters Degrees in both Physics and Computer Science. He is a Chartered Engineer and Member of the Institution of Engineering and Technology. Dai has consistently been recommended in the Legal 500 and Chambers Guides to the Legal Profession. Having been national head of Intellectual Property Law and later national head of Information

Technology law at Eversheds, Dai is now a partner in his own solicitor's practice, Percy Crow Davis & Co.

Ann Henry leads the IP and Data Litigation team for Pinsent Masons in Dublin. Ann was Chairwoman of the Intellectual Property and Data Protection Committee of the Law Society of Ireland from 2016-2018. She has been involved in numerous IP policy initiatives at national and EU level. She is a member of the Irish Government's Data Forum which sits in the Dept. of An Taoiseach and which considers data related issues relevant to the development of Ireland's digital economy. She has been involved in many of the leading cases to come before the Irish Courts. Most recently she advised the Data Protection Commission in Ireland in Schrems II, concerning the reference to the CJEU on the question of the validity of standard contractual clauses. She is currently advising on a number of patent litigation cases before the Irish Courts.

Gideon Shirazi

Gideon is a barrister at 4 Pump Court specialising in high-value, complex commercial litigation and international arbitration, with a particular focus on technology, data and IP licensing disputes.
